

ELIGIBILITY CHECK : SMART AND SKILLED FUNDED TRAINING

STEP 1

You must be all of the following:

I am an Australian Citizen, permanent resident or humanitarian visa holder



I am aged 15 or older



I am not at school



I live or work in NSW



YOU ARE ELIGIBLE FOR SUBSIDISED TRAINING

STEP 2 *Do I get a further subsidy or no fee for my training?*

I must meet one of the following eligibility criteria

I am Aboriginal or Torres Strait Islander

I am long term unemployed

I am a migrant or refugee who is unemployed or underemployed

I have a disability or I am a dependent of disability benefit holder

I am a low income Commonwealth welfare recipient or dependent.

Bridging Visa A,B,C,D or E holder on humanitarian grounds



Yes? You may be eligible for a subsidised full qualification. Call us to calculate your fee.

When applying for Smart and Skilled funded training you must supply evidence to support your eligibility criteria. This will include signing a statutory declaration and providing a letter from a medical practitioner or government agency.

Eligible Centrelink benefit evidence includes:

- Parenting Payment (single)
 - Special Benefit
 - Newstart Allowance
 - Widow or wife pension
 - Aged pension
 - Austudy
 - Carer Payment
 - Exceptional circumstances relief
 - Youth Allowance
 - Family Tax Benefit Part A (maximum rate)
 - Farm Help Income Support
 - Sickness Allowance
- Please note: a Centrelink Health Care Card is acceptable evidence, not a Medicare card.

OR

I am experiencing one of these barriers

- I'm physically ill
- I can't afford childcare for training
- I find conversation and/or reading and/or numbers difficult
- I can't afford transport for training
